

VACANCY—Design Review Advisory Board

Pursuant to Section 6-13 of the Dedham Home Rule Charter, the Board of Selectmen calls the attention of all residents and others to the fact the following vacancies exist.

Design Review Advisory Board—Three members
Design Professional—Appointed by the Board of Selectmen
One (1) three year term to expire 2015
Design Professional—Appointed by the Planning Board
One (1) three year term to expire 2015
Design Specialist—Appointed by the Historic District Commission
One (1) two year term to expire 2014

About the Design Review Advisory Board

The Design Review Advisory Board (DRAB) shall develop, with assistance and input from local civic organizations and interested citizens, design guidelines for areas of town having different visual and functional character. Administrative and logistic support for DRAB shall be provided by the Planning Board, but the Board may also seek support and advice from the Historical Society and other entities and individuals concerned about Dedham's visual character.

The Board shall meet at the call of the Chair to review and made recommendations for building projects as defined below.

The Board shall review and advise on all new construction, additions to exterior alterations of existing buildings, and all new signage or alterations of existing signs in the Central Business (CB), General Business (GB), Highway Business (HB), Local Business (LB), Limited Manufacturing (LMA), Limited Manufacturing Type B (LMB) and Research Development and Office (RDO) districts; as well as all projects subject to parking plan approval, site plan review or Major Nonresidential Projects or requiring a special permit or variance from the Board of Appeals, if located in RDO, PC, PR or LM districts.
