



**TOWN OF DEDHAM BUILDING DEPARTMENT
FORM 7
DEMOLITION/DEBRIS**

THIS FORM MUST BE COMPLETED IN ORDER TO OBTAIN A PERMIT FOR THE CONSTRUCTION, DEMOLITION, RENOVATION, REHABILITATION OR OTHER ALTERATION OF ANY BUILDING OR STRUCTURE. IF THE APPLICANT IS RESPONSIBLE TO REMOVE/DISPOSE OF THE DEBRIS, THE DISPOSAL SITE MUST BE IDENTIFIED BEFORE THE PERMIT IS APPROVED. IF THE APPLICANT CONTRACTS FOR THE REMOVAL/DISPOSAL, THE CONTRACTOR/HAULER AND DISPOSAL SITE MUST BE IDENTIFIED BEFORE THE PERMIT IS APPROVED. **IF THE DISPOSAL SITE IS CHANGED, THE PERMITTING AUTHORITY (BUILDING DEPARTMENT) MUST BE NOTIFIED.** THE PERMITTING AUTHORITY MAY REQUIRE PROOF OF LAWFUL DISPOSAL BY SUBMISSION OF A DISPOSAL RECEIPT, OR CERTIFICATE FROM THE DISPOSAL OPERATOR.

IT IS A CRIME TO DISPOSE OR CONTRACT FOR DISPOSAL OF SOLID WASTE IN AN UNAPPROVED SITE. THE MAXIMUM PENALTY FOR ILLEGAL DISPOSAL IS \$25,000.00, AND 2 YEARS IN A HOUSE OF CORRECTION
